## SCHEDULE OF BILLING

New students needing a confirmation of enrolment must make payment for a minimum of one semester tuition fee and one semester of boarding fee (if applicable), plus the application and enrolment fee and overseas student health cover (for the total duration of study at Wilderness.)

Continuing students are invoiced in December of each year for the following school years' annual tuition charge and annual boarding charge (if applicable). Payment in full is due by 15 January.

Accounts are also issued at the end of each school term for any additional charges for non-compulsory items not covered by the annual tuition and boarding fee.

Fees and charges may be paid by cash, cheque, international bank transfer or telephone/internet banking (BPay).

The School maintains the right to recover all expenses incurred in pursuing recovery of overdue amounts including, but not limited to, legal fees, administrative costs, location and service fees and any commission payable to debt recovery consultants. Where payment is not made by the due date a late payment administrative fee of \$70 will be charged, unless prior arrangements have been made with the School.

The School is entitled to charge interest at the overdraft rate used by the School's Bankers, plus 1% per annum, calculated on a daily basis. The rate will fluctuate from time to time and will be advised prior to charging. Any account unpaid by due date may incur interest at the rate notified by the School.

Fees must be paid in full by 15 January. All fees must be paid in Australian dollars and refunds will be reimbursed in Australian dollars. In the event of continuing default, the School reserves the right to notify parents that their daughter will not be permitted to return to Wilderness until fees, charges, arrears and interest have been paid.

## CONCESSION FOR SISTERS

Where younger sisters attend the School at the same time, a 10% discount applies to the second child, a 15% discount applies to the third child and a 20% discount applies to the fourth child. These discounts apply to the portion equivalent to the domestic tuition fee and domestic boarding fee components only.

## TUITION FEES

The tuition fee quoted covers all standard compulsory curriculum requirements including excursions, camps, theatrical performances and most costs associated with the sporting programmes offered by the School. The quoted fee does not include the cost of textbooks and stationery purchased for some subjects, private tutoring, interstate and overseas visits, private music tuition and musical instrument hire, school bus service, After School Care and the cost of the school uniform. An additional levy is payable where a girl chooses to participate in the School's rowing programme (costs vary each season).

If a student's visa changes during a year the international tuition and boarding fee will remain until the conclusion of that academic year.

## BOARDING FEES

Students are required to vacate the Boarding House at the end of each term, however they are allowed to leave their belongings in their rooms during term breaks, excluding the Christmas holiday. The Boarding House will be closed during term breaks and will not be accessible to students.

Exeat weekends are weekends when local boarding students return home. To cover meals and staffing costs, international students who remain in the Boarding House during these weekends will be charged a fee of \$100/per night. During periods when the Boarding House is closed; Term holidays, Easter or those exeats when numbers requesting to stay are limited, girls are placed in home stay accommodation arranged by Happy Homestay (fees specified on previous page).

The **recreation allowance** is used to cover entertainment expenses organised by the Boarding House or groups of Boarders and the purchase of recreational equipment. The allowance is compulsory and non-refundable. Should the allowance be exceeded the excess will be charged to the fee account.

The **annual ancillary charge** is a compulsory charge for students that board only. It will cover incidental charges incurred during the year for such items as taxi's, instrumental music (optional) and exeat weekend stays (when there is sufficient students to remain in the Boarding House). Any balance remaining from the ancillary charge at the end of the academic year will be carried forward to the following years school fee account. Any balance remaining at the conclusion of the students academic stay will be refunded.

## LEARNING COMMONS VOLUNTARY EDUCATION CHARGE

The Learning Commons Voluntary Education Charge is a once only charge used towards funding the build of the new Learning Commons, a new facility to be used by all students, staff and the Wilderness Community. It is due for completion in early 2020.

## NOTICE OF WITHDRAWAL & REFUND POLICY

A full term's written notice must be provided to the Principal where a student is to be withdrawn from the School otherwise 10 weeks of the relevant annual Tuition fee and Boarding fee (if applicable) will be payable in lieu of notice.

Boarding places are allocated and the applicable boarding fees are payable for the whole year unless a student is accepted for a lesser period.
